## ONE FORM OF PRIMARY IDENTIFICATION IS NEEDED FOR CERTIFIED COPIES OF BIRTH OR DEATH RECORD. (MUST BE CURRENT AND VALID)

- STATE ISSUED DRIVER'S LICENSE (WILL NOT ACCEPT TEMPORARY ID FROM DEPARTMENT OF MOTOR VEHICLES)
- STATE ISSUED IDENTIFICATION CARD
- MILITARY ID OR VETERAN'S ID
- VALID PASSPORT, IN ENGLISH OR WITH ENGLISH SUBHEADINGS MUST BE PART OF PASSPORT
- VALID IMMIGRATION CARD ISSUED BY THE CONSULATE FROM THE COUNTRY OF BIRTH. (MUST BE IN ENGLISH).

## IF INDIVIDUAL DOES NOT HAVE A PRIMARY DOCUMENTATION, TWO FORMS OF SECONDARY DOCUMENTATION ARE REQUIRED:

- WORK CARD OR BADGE WITH PICUTRE AND SIGNATURE (MUST BE CURRENTLY EMPLOYED)
- SCHOOL ID WITH PICTURE AND SIGNATURE (MUST BE CURRENTLY ENROLLED)
- INDIANA ONLY PROFESSIONAL LICENSE
- MOTOR VEHICLE REGISTRATION (MUST BE VALID) WITH SIGNATURE (NO TITLE)
- $\bullet$  PREVIOUS STATE (IT-40) OR FEDERAL TAX RETURN (1040) WITH SIGNATURE AND SOCIAL SECURITY NUMBER
- INDIANA GUN PERMIT WITH SIGNATURE
- PROBATION PAPERS CERTIFIED FROM COUNTY PROBATION DEPARTMENT WITH INDIVIDUAL'S NAME AND DATE OF BIRTH
- DEPARTMEN OF CORRECTION ID (ISSUED WITHIN THE PAST SIX MONTHS)
- VOTER REGISTRATION WITH SIGNATURE
- GREEN MEXICO CONSULAR ID CARD
- SOCIAL SECURITY CARD WITH SIGNATURE
- SIGNED MORTGAGE OR HOME RENTAL AGREEMENT
- MILITARY DISCHARGE PAPERS (DD-214)

OTHER DOCUMENT MAY BE ACCEPTED AT THE DISCRETION OF THE HEALTH OFFICER. AN INDIVIDUAL WHO HAS NO FORM OF ID LISTED ABOVE SHOULD ASK SOMEONE ON THE ELIGIBLE PERSONS LIST TO OBTAIN THE RECORD FOR THEM.
