To vote a straight Republican, Democratic, or Libertarian ticket for all Republican, Democratic, or Libertarian candidates, except for candidates for County Council Member At Large, make a voting mark on or in the box of the corresponding party, and do not make any other marks on this ballot.

To vote for any candidate for County Council Member At Large you must make another voting mark for each candidate you wish to vote for. Your straight party vote will not count as a vote for any candidate for that office. If you wish to vote for a candidate seeking a nonpartisan office or on a public question you must make another voting mark in the appropriate box on the ballot.

To vote for a write-in candidate, completely fill in the box provided to the left of the words "Write-in" and write in the name of the candidate on the line provided. A write in vote will not be counted unless the vote is for a declared write-in candidate.
