CASS COUNTY COMMISSIONERS December 5, 2022

The Cass County Commissioners met at 1:00 p.m. in the Commissioners Hearing Room. Present for the meeting were Ruth Baker, Mike Stajduhar, Attorney Jeff Stanton, and Auditor Cheryl Alcorn. Ryan Browning was absent.

Ruth Baker opened the meeting with the Pledge of Allegiance.

AMEND AGENDA – Commissioner Baker requested additional agenda item to entertain bids for Broadband Internet Infrastructure to the agenda.

Mike Stajduhar made a motion to amend the agenda as requested, Ruth Baker seconded. Motion carried unanimously.

MINUTES – Mike Stajduhar made a motion to approve meeting minutes, Ruth Baker seconded. The motion carried unanimously.

CLAIMS & PAYROLL- Mike Stajduhar made a motion to approve the claims and payroll as presented, Ruth Baker seconded. The motion carried unanimously.

EMS – Brady Wiles presented the monthly report for November. EMS responded to 349 calls and provided 450 transports. Average response time of 6:55.

Brady reported 1381 billable miles consisting of 125 ALS and 6 Level II ALS calls and 97 BLS calls. Total billed for October \$263,197. Currently the department is fully staffed with one position on workman's compensation. One ambulance has been fully wrapped with new county logo design.

PARK DEPARTMENT – Dana Hildebrand presented the monthly report for November. Estimated revenue for November \$14,279. Revenue received In October for the Sleepy Hollow event was \$3,334. Crews continue park maintenance and splitting firewood for next camping season.

George reported Logansport Memorial Hospital has offered a 30% discount for services provided to the County Coroner, to be retro-active as of January 1, 2022. Memorandum of Understanding (MOU) will be presented to Commissioners at next meeting for approval.

Tara reported hiring two new employees and interviews are scheduled for next week to fill remaining three vacancies.

HEALTH DEPARTMENT – Serenity Alter was not available to attend meeting. The following monthly report for November was submitted and reviewed. Health Department held 14 routine immunization clinics and 384 patients were seen with 722 vaccines given. COVID and Flu vaccines are being offered to the public.

Vital Records department received \$2,995 in document fees. The department printed 135 birth certificates, 210 certified death certificates, 2 paternity affidavits and 1 genealogy search.

Mike Collins completed 50 restaurant inspections, 4 pre-operational, 2 complaints, and issued 50 food permits. Mike conducted 1 environmental inspection, 1 lead follow-up, 5 pool inspections and 1 pool follow-up, and 4 tattoo salon inspections. Dan Musselman completed 9 environmental calls, 8 soil reports, 2 repair permits, 3 new construction permits, 5 septic system permits, 7 residential septic location searches, and 0 requests to connect to existing OSS systems.

The department continues to offer COVID vaccines at the Health Department on High Street. COVID vaccine is by appointment on Tuesday and Thursday from 7 a.m. to 7 p.m. COVID-19 rapid antigen test kits are available at no cost.

HIGHWAY DEPARTMENT – Jeff Smith presented the monthly report for November. Jeff announced the CR 400 S project is now fully open. The multiphase project took nine years to complete and 13.8 million-dollars, majority paid with federal and state funds with remaining paid through local CEDIT funds. Project connects State Road 29 with State Road 25 and provides

another truck route to the Clymers Agri-Business Park, along with connectivity to the airport and Logansport Industrial Park.

Jeff reported the Hoover Bridge repair work is underway and should be completed this week. Winter operations have started with a minor snow fall resulting in approximately 8 hours of overtime for spot-sanding slick-spots.

Department is preparing for multiple large projects in the coming year. Two large scale fiber installation projects for the Appleseed solar project and gas line installation from the Boone Township NIPSCO plant to Kokomo for new Stellantis EV battery plant. Clymers Agri-Business Park road improvements are anticipated to begin late next year, community crossing grant application will be submitted for funding.
