

CASS COUNTY COUNCIL
January 17, 2020

The Cass County Council met at 9:00 a.m. in the Commissioner Hearing Room. Present were Brian Reed, Bruce Ide, Grover Bishop, Mike Stajduhar, Dave Redweik, Tracy Williamson, George Stebbins, Attorney Jeff Stanton, and Auditor Cheryl Alcorn.

Mike Stajduhar opened the meeting with the Pledge of Allegiance and a moment of silence following.

RE-ORGANIZATION – Mike Stajduhar turned the meeting over to Auditor Cheryl Alcorn. Auditor Alcorn requested nominations for council president. Grover Bishop made a motion to retain the current slate of officers, Mike Stajduhar as President and Brian Reed as Vice President, George Stebbins seconded. The motion carried unanimously.

Auditor Alcorn turned the meeting over to Council President Stajduhar.

MEETING MINUTES – Brian Reed made a motion to approve the regular meeting minutes as presented, Bruce Ide seconded. The motion carried unanimously.

ORD. 20-01 SALARY AMENDMENT – Dave Wegner requested approval of amendment to correct probation salary error in the amount of \$1,538.00. Probation salaries are based upon years of experience per state approved salary schedule. Year of experience increase for one officer was inadvertently overlooked. George Stebbins made a motion to approve Ordinance 20-01 Salary Amendment, Grover Bishop seconded. Motion carried unanimously.

SALARY AMENDMENTS – Judge Kitts requested approval amending stipend amount for court reporters hired after January 1, 2018 of \$2,000 in addition to the current \$2,000 stipend. George Stebbins made a motion to approve court reporters hired after January 1, 2018 shall receive a total stipend amount of \$4,000, Brian Reed seconded. Motion carried 6 in favor; 1 opposed. Bruce Ide opposed.

ORD. 20-02 SALARY AMENDMENT & ORD. 20-03 SALARY AMENDMENT – George Stebbins made a motion to approve Ordinance 20-02 and Ordinance 20-03 amending

stipend amounts for court reports hired after January 1, 2018; retro pay as of January 1, 2020, Brian Reed seconded. Motion carried 6 in favor; 1 opposed. Bruce Ide opposed.

PUBLIC COMMENT- None


ADJOURNMENT – George Stebbins made a motion to adjourn, Brian Reed seconded. The motion carried unanimously.
