

CASS COUNTY COUNCIL
March 18, 2022

The Cass County Council met at 9:00 a.m. in the Commissioner Hearing Room. Present were Brian Reed, Tracy Williamson, Dave Redweik, Damon Foreman, Dean Davenport, Attorney Jeff Stanton, and Auditor Cheryl Alcorn. Bruce Ide and Shawn Shoemaker were absent.

Brian Reed opened the meeting with the Pledge of Allegiance.

MEETING MINUTES – Dave Redweik made a motion to approve the regular meeting minutes as presented, Dean Davenport seconded. The motion carried unanimously.

ADDITIONAL APPROPRIATION –

- Prosecutor requested additional appropriation from Pre-Trial Diversion Fund 2529 in the amount of \$9,000 for Pre-Trial Diversion.

Tracy Williamson made a motion to approve the additional appropriation from Fund 2529 in the amount of \$9,000, Dave Redweik seconded. Motion carried unanimously.

- Coroner requested additional appropriations from General Fund 1000 in the amounts of \$10,000 for Autopsy Fees, \$5,000 for Toxicology Fees, \$2,000 for other supplies, \$5,000 for contractual services, and \$2,500 for personnel.

Dave Redweik made a motion to approve the additional appropriation from Fund 1000 in total amount of \$24,500, Tracy Williamson seconded. Motion carried unanimously.

- Assessor requested additional appropriation from General Fund 1000 in the amount of \$139,758 to recover the 1782 Notice reduction to cover cost of Reassessment Service Contract.

Dave Redweik made a motion to approve the additional appropriation from Fund 1000 in the amount of \$139,758, Tracy Williamson seconded. Motion carried unanimously.

RES. 22-02 CAPITAL NON-REVERTING FUND TRANSFER – Brian Reed presented resolution to transfer \$350,000 from Capital Non-Reverting Fund to Redevelopment Commission Fund for reimbursement of attorney fees incurred in defense of alleged Open Door Violation lawsuit.

Tracy Williamson made a motion to approve Resolution 22-02 Capital Non-Reverting Fund Transfer.

Upon discussion the motion died for a lack of a second.

PUBLIC COMMENT- Lora Redweik, 5524 N CR 600 E, Twelve Mile – Concerns of how the funding to purchase fire truck was not addressed at the June meeting of the Redevelopment Commission. Disappointed in the funding arrangement, thank you for not seconding the motion to approve resolution.

RECOGNITION – Council recognized former County Councilman Grover Bishop for eleven years of dedication to the county.

Grover Bishop explain eleven years ago he felt it was his turn to serve the community. Appreciate working with the Council and the dedicated county employees. Hope that in the long run our efforts are appreciated, sometimes they get overlooked. Thank you for the opportunity to serve.


